# Civil Society Program

The recent changes in the country, particularly admission to Council of Europe shaped our programs in Civil Society, Mass Media and Law. The commitments that the country undertook to meet as a new member of the Council of Europe (CoE) have activated to the democratic processes. Having aimed to foster democratic reform in Armenia, cultivate liberal ideas by promoting the rule of law, human rights including rights of minorities and other vulnerable groups, and furthering exercise of competent public power, the goals and initiatives of Civil Society program are directly related to the needs imposed by the membership. The strategy that we employed for the last two years, i.e. expanding of the Civil Society mandate to all areas of programming, proved to be efficient since the objectives of the Civil Society are essential to the mission of the Foundation.

In close cooperation with programs of the Foundation particularly Law, Information, Education and East-East, the Civil Society program of the OSIAF-Armenia addressed a very important need raising of public awareness of human rights and spreading the idea of tolerance in the society. These are fundamental needs for any society, as tolerant mentality of every individual can provide general tolerance of the society and build democratic and civil society.

As a Member of Council of Europe Armenia undertakes to guarantee that all churches or religious communities, in particular those referred to as "non-traditional" may practice their religion without discrimination. In this aspect, the OSIAF-Armenia supported the project that aimed to promote religious tolerance in Armenian society through raising public awareness of religious minority issues; to organize three seminars and broadcast on TV three round tables with participation of representatives of Armenian Apostolic Church and different religious confesses in Armenia. In the course of the project, a mass media monitoring of the issue of religious tolerance has been conducted and will be summarized in a series of three brochures. The amendments to the Law on Freedom of Conscience and on Religious Organization have been developed, and submitted for public discussion.

Armenia has undertaken to sign and ratify the "European Charter for regional and Minority Languages". The Civil Society program has supported a project in the framework of which the concept paper for the law on "National Minorities" has been drafted and submitted for discussion, comprehensive study on demographic, economic, cultural, educational status and needs of minority groups has been conducted, policy recommendations developed for state bodies and different donor agencies.

Due to deepening impoverishment and yet high emigration rate, prostitution and trafficking among human beings have become a severe problem. The scale and increasing numbers aggravated the situation, since no institution, i.e. legal framework, education system, and public health is ready to adequately address the multifaceted problem. The Civil Society and Women's Programs have started projects to address the legal, rights protection, and public health aspects of these problems.

The Civil Society program has also supported the project that aims to make in-depth analysis of causes, extent and governmental policy influence on increase of emigration from Armenia.

The Civil Society program in cooperation with the Health program supported "Children Rehabilitation Fund" NGO to integrate disabled children into society by conducting innovative psychical, medical, rehabilitation and socio-psychological methods of treatment, to provide socio-psychological assistance to the members of the families of disabled children, to establish an entity for conducting the above-mentioned activities.

The Civil Society program in cooperation with Information program has supported creation of a web site "Human Rights in Armenia" (<a href="www.hra.am">www.hra.am</a>) and supported preparation and publishing of a monthly periodical the "Human Rights Bulletin". The Bulletin will introduce the results of monitoring of the implementation of the country's commitments as of a member of the Council of Europe.

Within the Civil Society we addressed one particular area concerning Seismic protection of population. The Foundation supported training of 150 local government authorities on introduction and implementation of comprehensive policies on how to respond in a devastating earthquake.

The Law Program of the OSIAF - Armenia aims to promote the rule of law, by making high quality legal education available for law students and raising awareness of general public of ongoing legal reform and providing access to competent legal aid to vulnerable groups, and working towards improving conditions in closed institutions. The Program also prioritizes furthering of harmonization of legal framework and legal practices with European and International Human Rights standards and monitoring of implementation of the commitments that Armenia undertook as a member of the Council of Europe.

To make legal information and legal services accessible, a center for free legal aid started its work in the structure of the Bar Association of the Republic of Armenia (BARA) in close cooperation with the Legal Clinic at the YSU with the OSIAF - Armenia support. The access to justice project widened the scope of the target population by establishment of three branches in the regions.

In cooperation with the OSCE we have supported the Law Institute of the Ministry of Justice for a series of training courses on International standards and basic Human Rights for penitentiary staff. To make the transfer of penitentiary system from the Ministry of Internal Affairs to the Ministry of Justice full and thorough, one needs to make "transformation" in the attitudes and practices of the penitentiary staff, we work towards improvement of the conditions in closed institutions, trying to provide openness of the law enforcement and penitentiary system to public control and observance of human rights, including sanitary hygienic standards of imprisonment.

Aiming to address the core need for upgrading the university education in the area of law the Foundation supported development of courses on International Law at the Law Department of the Yerevan State University (YSU), which provides with the need in legal cadre knowledgeable of the standards and requirements of the International HR Court. The YSU has recently institutionalized this initiative by establishing a specialization in International Law for graduate studies.

At the same department the Foundation together with Constitutional and Legal Policy Institute continues to support Legal Clinic. The Clinic has aimed to support the professional development of the faculty and to foster the process of capacity building at the Law Department. During these three years legal clinic has growing into a part of compulsory course for students of Masters Studies of Law Department. The Clinic has started a new component of Street Law. During this time clinic has been functioning. It has already attracted donor attention and best achievements of the Law Program of the OSI AF - Armenia and of the Law Department of the YSU.

The Law program in cooperation with Constitutional and Legal Policy Institute supported the project, which aimed to familiarize recruits, soldiers and officers on their rights, responsibilities and on basic laws on military services through publishing and distribution the special brochure.

The OSIAF – Armenia together with Constitutional and Legal Policy Institute supported a small project in the framework of anti-corruption program with particular emphasis on newly introduced decentralized system of secondary education in the country. The purpose is to study the legislation, policies and practices to identify the most susceptible areas for abuse and corruption.

The OSIAF - Armenia Women's Program consists of two parts: National and Network programs.

Since 2000, the OSIAF - Armenia National Women's program became an Institutional Partner (IP) grant program. "TRUST" Social Work NGO has become an IP for the National program.

The OSIAF – Armenia Women's Program Strategy is based on the following priorities.

- 1. To promote Gender Education.
- 2. To conduct Women Leadership Development seminars.
- 3. To promote women's rights and to introduce the gender integrated approach to political, social, economic, and domestic spheres of Armenian society.

In 2001, the IP continued its work to promote gender socialization, to further women's leadership development and gender education.

Teacher's Manual (Methodology for Gender Education) has been published in both languages: Russian and Armenian.

The developed methodology for Gender Education was successfully tested in high schools and colleges. The IP provided training sessions for teenagers in high schools and mixed groups of students from different colleges using the developed methodology. The education process was combined with surveys of teachers and teenagers, which gave better understanding of the level of social awareness on gender issues. The IP conducted Women Leadership Development training sessions. In 2001, "TRUST" has conducted the training sessions with different groups and continued the sessions with the previous group.

The following activities have been also done in the scope of Network Program.

- Under the umbrella of "TRUST" the Project on Domestic Violence Prevention is implemented. The main goal of the Project is to identify the existence of such social phenomena as domestic violence in Armenian society and to raise public awareness on that problem through the organizing training seminars with groups of professionals.
- The OSI AF-Armenia is actively participating in such network program as "Gender Policy and Mass Media". The goal of our Foundation in "Gender Policy and Mass Media" program is to produce film on gender issues. The film made by Armenian producers explores so serious problem for Armenia as migration from gender point of view.
- The book "Women's Human Rights: Step by Step" was translated from English into Armenian by "Women's Human Rights Center" NGO.

# Mass Media Program

The goal of the Mass Media Program is to foster independent, objective and pluralistic media in Armenia through assistance to the establishment of a favorable and progressive legislative environment, professional development of journalists and media managers, their access to new communication technologies and focused assistance to regional media. The program promotes country's integration into European and international structures, primarily the Council of Europe, by supporting the process of bringing of Armenian legislation into line with the country's international obligations in the media sphere and by ensuring implementation of commitments in this areas.

In accordance with the goals and strategy of the Mass Media program the YPC implements the project, that aims: a) to bring mass media and information sphere legislation in accord with European and International standards and provide legal protection for journalists and MM institutions, b) to develop and adopt common professional norms and international standards in Armenian journalism community, c) to form a group of journalists specializing in coverage corruption issues, and to conduct focused and long-term training for the group, d) to modify curricula for journalism studies, to renew and enhance the library stock, and e) to upgrade level of teaching at the Journalism Department of the YSU and at complimenting studies at Yerevan State Linguistic University, f) to present weekly coverage of Armenian media and journalism in electronic bulletin and to assist leading Armenian media to create web-sites.

The other IP, "Internews" Armenia has been funded to develop a network for information distribution by means of modern technologies. To use the network in order to enhance access to information and diversify content of the regional media as well as disseminate local information throughout Armenia.

"Internews" Armenia activities are to support <a href="www.media.am">www.media.am</a>, focused on content development of the web site: to diversify and expand the news, legislation, information and analytics parts, to open on-line consultation for professionals of media and information sphere, where they will be able to receive high quality information concerning issues of TV, radio, IT, access to information and freedom of information, to support investigative journalists' website (<a href="www.hetk.am">www.hetk.am</a>), where materials of investigative journalists are published, to investigate the opportunity of audio-video information exchange and approbation of Internet video exchange, to establish constantly resource center "Internet training for Journalists" and promotion teaching information for journalists.

More important is the launch of the GIPI, which in Armenia became a natural development of our legislative work in media and will be implemented by our media partner, "Internews" Armenia. In Armenia the activities of GIPI are primarily focused on providing assistance to local authorities and civil society groups in adoption of Information Communication Technologies (ICT) legislation and relevant self-regulation mechanisms, including but not limited to:

- drafting the law on electronic signature and electronic document;
- providing expertise on the draft law on media (in the part related to Internet);
- providing expertise of the draft law of friedla (in the part related to interne
- evaluation of the implementation of the National ICT Development Strategy;

policy advice in the area of regulation of the telecommunications market;

- assisting national Internet domain registrar in development of dispute resolution policy;
- study of Internet and telecom market and publication of relevant analytical materials;
- initiating public discussion of the issues related to development of Internet in Armenia;
- other activities related to formation of public policy on ICT, Internet and telecommunications.

The program aims to introduce and implement the concept of community education through establishing community schools in Armenia. In support of this the OSIAF-Armenia pursues its Community School and Telecenter development activities bringing in regional expertise and experience, and institutionalizing the models within the Educational Reform Center. Thus, in the framework of the East-East Program and with expert support from the IEP, the concept of an Armenian model for community schooling has been debated and developed with participation of large community of educators based on the materials of international conference "Creation of Socially Active Schools" held in October 2001. The local models were endorsed by the Ministry of Education and the Center for Education Reform.

The Foundation cooperates with the USIS-funded school connectivity project implemented by the "Project Harmony", that provides connectivity and hardware to schools. Along with ensuring scalability and sustainability of the model, this cooperation permits us to focus our resources and efforts on training and content development needs. The Foundation, in the framework of the National Education and Information Programs, supports computer-training programs (four levels: basic skills – 200 teachers trained, advanced training - 570 teachers trained, web-design 300 - teachers trained and usage of educational modules-102 teachers trained) to the teachers of the schools supported by the OSIAF-Armenia, "Project Harmony" and the World Bank. Moreover, our TCs have become advanced enough to provide computer training to the school staff and communities. For example, the Teachers Union in a provincial city of Goris trained 200 teachers of Syunik region. ATC in Vanadzor provided computer trainings to the accountants of other schools of the city, as well as to the children of Vanadzor orphanage. The TC in Gyumri provided computer training to the professors and post-graduate students of Gyumri State Pedagogical Institute. The above mentioned projects are good examples of providing life-long education by TC-s to local community members. The TC is also established in Boarding school for children with hearing problems, which will foster the integration of disabled children into the society.

Building up on the capacity of the Community schools and TCs, creation of an Interschool WEB-portal has been supported by the Foundation. The Portal serves as a tool for distance learning and life-long education. It is deemed to become a resource for educational content that the Foundation and other donors support, a space where the information on educational of the different government bodies shall be posted, and, most importantly, the portal will provide space for exchange and debate to educators and students. It will provide against disintegration and school alienation that the decentralization of the system has already brought as a by-product. Materials of all our programs (i.e. I\* EARN, SBS, RWCT) are available through portal.

The education content development initiative has continued: the courses developed with the Foundation's support are now taught in 110 schools. In content development the Foundation has taken a different and more comprehensive approach. In the framework of the Information Program with the full support of the OSI AF-Armenia the educational multimedia WEBCT has been translated and adapted to Armenian language, and two new courses developed. The WEBCT is one of the most comprehensive software for distance education, since it provides a unified framework to any subject. It gives an opportunity to use developed software interface for further course development on other subjects, without additional cost on development of the technical part. The program will be available on Internet, at the Portal, and CD-s.

As of October 2000 the SBS and RWCT programs of the OSIAF Armenia had been span off and a newly established NGO SBS Benevolent Foundation" had become an institutional partner of OSI for these two programs. Since the start of the IP grants along the requirements of the founder, OSI NY, the NGO has appointed a board of directors.

In 2001 the SBS continued to work with kindergartens, schools, pedagogical universities, colleges, and the Educational Reform Center.

In 2001 the number of preschool classrooms increased and reached 56. In September 2001, 32 new first grade, 32 second-grade, and 10 third-grade classrooms were opened throughout the country. In 2001 establishment of 5 Preschool Training Centers was completed. The centers were furnished and equipped to provide training and mentoring to new kindergartens interested in joining the SBS Program. Fifty additional preschool classrooms got SBS training through these training centers.

Selection and training of 5 primary model sites was implemented by late autumn of 2001.

The RWCT program started in 1999 and the timeframe for its implementation was designed for 3 years. The program works with teams of schoolteachers, university faculty, and teacher trainers to share with them interactive methods of instruction, and to assist with adapting those methods to the local educational context.

In March of 2001, the second round of workshops were conducted by the original group of participants for the newly recruited 120 educators coming from different regions of the country. The last centralized workshop was held in mid May.

In autumn of 2001 the final round of workshops was completed for the second-generation trainees. Recruitment of the third generation participants was initiated in mid November.

During their March visit, the RWCT volunteers conducted a mini seminar on certification issue with the original group of participants. In autumn a small group of 3-4 people will be certified as RWCT teachers and teacher trainers, and afterwards – as RWCT certifiers. This group will later take the responsibility of certifying other teachers and trainers.

Recognition of the methodology by higher education and teacher training institutions stands for the quality of the Program.

## I\*EARN Program

The OSIAF-Armenia has been supporting the I\*EARN Program since 2000. The Foundation's Institutional Partner, the Republican Children's Library, implements the Program. It furthers a school network establishment and fills the network with special content. Having gotten familiar to I\*EARN, children themselves will broaden the frame of I\*EARN topics and discussion groups. The Library has included the course of I\*EARN introduction into its Internet tutorial and widens the community of I\*EARN. Up to date 8 schools have been engaged in the project. Despite a very late start (most Foundations started I\*EARN much earlier) it gained pace very quickly and is among the projects that managed to get funding beyond our support. Including the Program into the WEB-portal provides the opportunity for the Program sustainability.

The OSI AF-Armenia Higher Education Support Program (HESP) aims to promote the advancement of higher education within the humanities and social sciences, encourage international contacts and incorporate research into higher educational institutions.

The priority areas of the OSI AF-Armenia are:

- 1. Building up the capacity for higher education policy development;
- 2. Supporting curriculum development and elaboration of teaching materials in the sphere of humanities, particularly political sciences and sociology.

The OSI AF-Armenia has already started support to higher education policy research and programs. In this aspect the OSI AF – Armenia is the first and the only organization that has promoted the adaptation and implementation of credit based system in Armenian Higher Educational Institutions. The project has started at Yerevan State Engineering University with the support of the Foundation. Transformation to credit based system will promote integration of Armenian Educational system into the International Educational System providing compatibility of Armenian educational system and the educational systems of developed countries.

The Foundation has also supported a program at the Yerevan State Linguistic University on development of standards.

The introduction of innovative curricula on humanities and social sciences is very significant for the country in preparing cadre for the society. Addressing this need, development of four courses has been supported: Usage of Multiple Intelligence Theory in Elementary School; Development of Critical Thinking in Elementary School; Course of Sociolinguistics; and Population Health Reproduction's Economical Basis in Terms of Market Relations.

In 2001 the OSIAF - Armenia External Education Programs incorporated the following basic directions of activities: 1) scholarships for students 2) short-term support schemes for university teachers and working experts and research support for grantees working in Armenia.

All programs promote development of social sciences and humanities in Armenia, thus fostering the establishment of open democratic society in Armenia. The programs provide Armenian citizens with opportunities of better access to information, exposure to the Western-type of educational system, as well as the possibilities of establishing ties with their colleagues from other countries for cooperation and exchange of experience.

Scholarship programs provided high quality educational services to the gifted students in various sciences, hence providing opportunities to them to continue academic career at Central European University (CEU), American University in Bulgaria (AUBG), Soros Supplementary Grants Program (SSGP), Global Supplementary Grants program (GSGP), and Human Rights Center-University of ESSEX.

Short-term support scheme programs, Curriculum Resource Center (CRC), Summer University (CEU SUN), were extremely supportive to Armenian educators in promoting the development of higher education in Armenia, as well as providing research opportunities for scientists.

In 2001 the OSIAF-Armenia further developed the External Education Programs by establishing contacts with local universities/institutes teaching humanities and social sciences, promoting the integration of the External Education programs' graduates into the Armenian society by involving them in teaching at local universities and community citizens in order to raise the impact of this programming area on the changes in the higher educational system of Armenia.

The OSI AF-Armenia continues to promote models of community access to Internet resources. Such approach will substantially increase the number of Internet users, thus creating basis for reaching the threshold of use. Based on the schools that are already supported, the OSI AF-Armenia will continue development of Community Telecenters, which provides Internet access to local community and in the meantime, addresses educational needs of the high school and community. Creation of the initial training capacity (human resources and training materials in Armenian) remains another important goal of the program, as well as development of Armenian language content tools and of the on-line local content.

In 2001 in cooperation with the OSI AF Armenia National Education and Information program 21 secondary schools continues implementation of community TeleCenter project. During this stage of project implementation diversity models are implemented in each TeleCenter taking into account various factors affecting the TeleCenter development.

In 2001 the OSI AF Armenia continues its strategic partnership with the USIS funded Project Harmony (PH). As in previous year the OSI AF Armenia shares his electronic educational content and funded training capacity with PH making it available in schools where PH implements its Armenian Connectivity 2000 program, while PH provides Internet connectivity and hardware support for the OSI AF Armenia funded TeleCenters.

The Foundation continues to build up the capacity of training programs established and supported previously. The programs have a different curricula and target groups, and thus cover both the need for extensive computer and Internet literacy training (four levels: basic skills – 200 teachers trained, advanced training - 570 teachers trained, web-design 300 - teachers trained and usage of educational modules-102 teachers trained) to the teachers of the schools supported by the OSIAF-Armenia, Project Harmony and the World Bank. Moreover, our training capacities have become advanced enough to provide computer trainings to their school staff and communities. It should be mentioned that the CISCO Regional Academy that the OSIAF Armenia and the OSI Information Program supported to establish in 2000 gained recognition and has been expanded and further developed by the USAID-funded donor, the Eurasia Foundation.

Training programs supported by the Foundation have become main training providers in Armenia.

The trainings sessions are conducted through previously sponsored training centers of ISOC and the Electronic Publishing Training center. ISOC prepares network administrators for Win NT or LINUX based networks.

In 2001 a comprehensive software solution for electronic educational content based on WebCT has been supported. WebCT has been translated and adapted to Armenian language application and two new e-courses on Biology and Chemistry will be developed. It gives an opportunity to use developed software interface for further course development on any subject, without additional cost on development of technical part. These courses will be available both online and on the CD- ROM media.

The Information Program gets incorporated with other Foundation programs. As a result of cooperation with National Education program, a web portal "Armenian Interschool Portal" (http://www.schoolnet.am), has been created. The portal serves as a tool for distance learning and life-long education. This portal will become a resource for educational content that the OSI AF Armenia supports. The creation of "Human Rights bulletin" (http://www.hra.am) web site is result of collaboration with the Law and Civil Society program. This website will serve as a forum for human rights organizations. As an outcome of cooperation with Arts and Culture program the web site of National Gallery of Armenia (http://www.gallery.am) has been developed and enriched with hundreds of electronic images of fine arts, sculpture, and graphics.



The Foundation started addressing inadequate legal framework in the area of Internet in Armenia since 2000 within the Media Program.

The GIPI project designed and implemented on regional scale has become a particular advancement in this initiative. It brings in best expertise and international perspective to the Internet policy development and advocacy.

The need of such project in Armenia is urged due to extremely suppressive monopoly on telecommunications and government intrusion on user privacy in Internet. Hence, the Foundation supported the regional initiative, the GIPI, to research and to develop progressive policies in the area of ICT. The Global Internet Policy Initiative supports adoption in Armenia of the legal and policy framework for an open and democratic Internet. The project works with local organizations in consultative, coalition-based efforts to promote the principles of a decentralized, accessible, user-controlled, and market-driven Internet.

The main directions of GIPI work in Armenia could be summarized as following:

- Providing assistance to the Ministry of Industry and Economic Development in drafting the law on electronic document and electronic signature. During the work on the draft law attention was paid on elimination of the provision restricting use of e-signature and other cryptographic software.
- Recommendations concerning the regulation of telecommunication market was developed and submitted to ICT Development Council. GIPI worked closely with the Ministry of Justice to assist the Government of Armenia in preparations for the negotiations of telecommunications tariffs with Armenian Telecommunication Company (ArmenTel).
- @ GIPI has been actively working to promote liberal registration regime for online media (voluntary notification). Relevant comments on the draft law on Mass Communications was prepared and submitted to the Ministry of Justice.
- GIPI also provided assistance to Armenian Internet Society in development of domain registration procedures and domain disputes resolution policy.

## Library Program

The main objective of the Library Program was creation of library automation network and Armenian bibliography with joint forces of leading libraries and National Book Chamber. Instead of encouraging libraries to develop separate standards for their electronic cataloguing, OSI experts recommended a universal standard. As a result, all records from libraries in Armenia were made available electronically in a single integrated system accessible across the country. The envisaged Armenian Automated Union Library Network (AAULN) hosted database architecture and record sharing facilities to support the preparation of the country's Electronic Union Catalogue, according to international standards.

In 2001 the OSI AF-Armenia's Library Program continued its support to develop of National Library Consortium. In the first stages of library automated project implemented in six major libraries of Armenia National Library of Armenia, Yerevan State University Library, Fundamental Library of National Academy of Sciences of Armenia, Scientific-Technical Library, Scientific-Medical Library and National Book Chamber. The consortium took ownership of Armenian library automation project and eIFL project.



The goals of the Publishing Program were to promote development of intellectual freedom and eliminate barriers of isolation through the publication and dissemination of books, which further valued open society and new ways of thinking. The OSI AF – Armenia Publishing program supported publishers and printers to upgrade their professional skills and to acquire knowledge on new technologies, including the sphere of electronic publishing, through participation in training sessions and in international conferences, workshops, and seminars. The program also supported projects aimed at content development in the sphere of electronic publishing, using and building on the existing infrastructure.


The OSIAF-Armenia through its Print Publishing Program participated in "Translation project" of the Next Page Foundation of OSI – Budapest. As a result, Next Page Foundation along with the OSI AF – Armenia Publishing program supported four Armenian publishing houses to translate and publish seven books from the Translation Project List in 2001. These books include many valuable titles both classical and modern authors, which were unfamiliar to Armenian readers. Besides the old CEU title list, which included many valuable titles, a new customized list was developed in order to fulfill local publishing needs.

The goals of Publishing program were to enable publishers and printers to modernize their professional skills, acquire knowledge of new technologies, and create direct contacts with western colleagues. For this purpose the Armenian publishers, printers, and booksellers will have an opportunity to participate in regional seminars and workshops in various countries of OSI Network, in Frankfurt Book Fair.

In 2001 the OSI AF - Armenia National Public Health Program focused on the Mental Disability Project to demonstrate alternative ways of addressing the issue. The OSIAF - Armenia's general approach to the Public Health program was to promote integration of mentally disabled people into society by raising public awareness of issues of the disabled, to create a model day care center to serve as a possible alternative to institutions, and a community-based family counseling service for the parents of disabled children.

The goals of the program were to:



promote alternatives to mental institutions;



integrate the mentally disabled into the society;



start a community-based family counseling service for family members and mentally disabled people.

The program was implemented by two Institutional Partners the "Armenian Mental Health Foundation" and "Khnamk" NGOs, which created a network of services to support people with mental illness. Two different models, a community-based accommodation and a day-care center for people with mental illness were created to serve the aims of the program.

The OSI AF - Armenia also supported initiatives of the OSI Network Public Health Program responding to the current needs of the country by disseminating information on competitions announced by the PH OSI-NY and by providing logistic and expert support whenever required. These are such programs as Geriatrics and Gerontology, Harm Reduction, European Health Management Initiatives and other competitions.

The OSI AF - Armenia participated in CDC-E-Learning program and XXIII Association of Schools of Public Health of the European Region (ASPHER) conference.

The OSIAF - Armenia Network program played a key role in providing professional development activities to medical/health professionals.

The Salzburg seminars, weeklong training courses had a purely clinical approach and were conducted in Salzburg, Austria by renowned professors from American medical institutes. The program was co-funded by the Austrian Government and provided training opportunities to a large group of physicians.

The Schweitzer program, administered by the Albert Schweitzer Institute, focused on health and ethics. ASI assisted the network to organize regional and sub regional conferences on issues of "Alcohol and Drug" in Budapest, "Strategies of HIV/AIDS Control" in Warsaw and "The Role of Professional Associations in the Licensing and Re-Validation of Physicians" in Budapest.

Both programs were focused on innovation and exposure to new ideas.

# Arts and Culture Program

The objectives of the OSI AF – Armenia Arts and Culture Program are to develop sustainable independent art sector, to upgrade arts management, and to increase the capacity of cultural policy development institutions. The program aims to facilitate the information society through application of new technologies in the field of arts and culture, and to promote the cultural diversity through dialogue and networking locally and internationally.

Organization of arts activities among vulnerable groups of society such as disabled children and juvenile prisoners received the highest priority support by the Arts and Culture program, which has been in close cooperation with Civil Society program throughout 2001. Overall four projects were granted aiming at social-psychological rehabilitation and integration of the mentioned groups into society through artistic and cultural activities. Particularly, a musical-creative center and a puppet theatre designed for both disabled and non-disabled children, as well as ceramic courses for thirty-five hearing-impaired children were supported. With the assistance of the OSI AF – Armenia a studio of fine arts, ensemble of dance and song, as well as theatrical and journalism groups started in the juvenile prison.

Projects facilitating education and training of cultural administrators, policy makers and arts managers were another priority for the Arts and Culture Program throughout 2001. The OSI AF – Armenia supported projects in the frames of which eight academic courses on arts and culture management for higher educational institutions are being developed and approbated, and 16 art administrators attended special training courses including arts and culture management, marketing, e-business, public relations and English.

Increasing the volume and quality of available information and application of new technologies in culture is of prime concern of the program as well. Within the framework of this aspect the Arts and Culture Program supported an initiative to enrich the web site of the National Gallery of Armenia with 400 electronic images of fine arts, sculpture, graphics and decorative art works, allowing on-line access to expositions and creation of virtual tours within the Gallery, as well as to teach the Gallery's administrators and staff of 20 people the basic computer knowledge.

The OSI AF – Armenia Arts and Culture program is particularly interested to encourage arts and culture initiatives from the Armenian provinces to foster cultural activities in rural areas that suffer from various social difficulties and lack of cross-boarder partnership and openness within the society. To pursue this goal in frames of the Cultural Policy network program we have supported a regional cultural quarterly journal initiative from Gyumri.

With an objective to promote cultural dialogue and networking with the countries of former Soviet Union and Eastern Europe, the OSI AF – Armenia actively took part in Arts and Culture Network competitions supporting both individuals to participate in regional and international cultural events, as well as cultural institution to organize hosting events in Armenia. Thus, four international gatherings devoted to the cooperation among independent video producers, mime groups and performers, artists and writers from different countries took place in Armenia in 2001.

The OSI AF – Armenia East East program aims to become a flexible resource to reflect the strategic priorities of the OSI AF – Armenia and the needs of civil society in enabling the exchange of experiences and facilitating long-term cooperation initiatives within the region of the Eastern Europe and former Soviet Union. The East East program is in fact a platform for both the OSI AF - Armenia and civil society organizations of the region to bring together their efforts to establish cooperation beyond borders towards the common goals of open society. We try to utilize the unique design of the program that allows to add value to what has been achieved by the national programs through facilitating the exchange of best practices and lessons learnt among specialists and policy makers of different fields.

#### Hosting projects aimed at development of cross-border cooperation.

The upcoming adoption of the new legislation on TV and Radio broadcasting in 2001 urged our Media IP – Yerevan Press Club, to organize an international workshop on Public and Private Broadcasting regulations with involvement of partner media organizations from Armenia, Azerbaijan and Georgia. The initiative resulted in creation of a regional network of journalists and media experts to work on synchronization of the media legislation in all three regional countries. Several recommendations that had been worked out during the workshop were taken into account while discussing the draft at the National Assembly.

Another initiative addressing regional cooperation and think tank development was supported within the framework of East East Program. Six leading experts from Eastern Europe conducted trainings for the representatives of local NGOs from Armenia, Azerbaijan and Georgia on public policy research methodology and strategy. Attendees also discussed problems, priorities, and opportunities for cross-border collaboration among public policy researches and policymakers that could help advance the concept of a Public Policy Research Institute in the region of the South Caucasus.

Fostering the reforms of educational system in Armenia corresponds to the programmatic goals of the OSI AF – Armenia. In close cooperation with the Education Program an international conference was held in Armenia gathering more than 90 participants from 7 countries to discuss the different models of socially active schools and find ways for the development of socially active schools in Armenia. As an outcome of the project the concept of Armenian Model for Community School was developed for larger community of educators.

#### Participation of Armenian specialists in international events.

The OSIAF – Armenia's East-East Program finds important the participation of local specialists in international projects with a major purpose to encourage their involvement in development processes as well as formation of professional networks and initiation of joint projects. We have many examples when in the result of attending East East projects our participants outstand with innovative ideas or initiatives. In 2001 the program paid special attention to projects corresponding to the strategic goals of the Foundation. Particularly Civil Society, Women, Public Health, Education programs received significant contribution from the East East program.
